

「Pet Health Dining Box」活動以及 ROYAL CANIN® Royal Canin Club 條款及細則

「Pet Health Dining Box」活動

- 1. 「Pet Health Dining Box」活動 (以下簡稱「活動」)由 Royal Canin Hong Kong Limited 主辦(以下簡稱「主辦方」),並全權負責活動的執行及管理。
- 2. 活動將受此等條款及細則以及活動詳情(統稱為「條款及細則」)約束。每位參加者同意已閱讀並理解此等條款及細則,並同意就參加活動受此等條款及細則約束。
